GENERAL INFORMATION

2019 FEES: Vendors will be charged a Flat Fee is \$300.00 EACH per STANDARD 10' x 10' Space or \$450.00 per EXTENDED 20' x 10' Space.

PLUS Electricity of \$40.00, if requested.

Includes: Two Week-end Tickets, Camping Wednesday, 8/28 thru Monday, 9/2.

A \$150.00 Security deposit is due with your application.

CONTRACTS: Vendors must sign a contract with Thomas Point Beach outlining their agreement and obligations.

LICENSES: Vendors are responsible for acquiring the appropriate State License and Local Licenses. Licensing inspections are conducted by the Local Authorities on the site.

FACILITIES: Power at Thomas Point Beach is limited and is available on request. (\$40.00 additional per outlet)

VENDOR STAFF: You will be provided with TWO 4-day Admission Passes per unit (only). These passes are to be worn throughout the full week-end and are only available for the actual ticket holder. If more are needed, they must be purchased. Please inquire about discounted employee tickets at 50% off listed prices. Limit 2 per vendor and intended only for employees, not valid for friends and family.

HOURS OF OPERATION: Open by 10:00 AM and CLOSE no later than 10:00 PM, each day; Thursday, Friday, Saturday and Sunday. (Wednesday OPTIONAL)

CAMPING: Vendors are welcome to camp on the property starting Wednesday, August 28 thru Monday, September 2 at no charge. Camping fees of \$25.00 per night will be charged prior to Wednesday. Limited camping areas are available behind vending space.

RESTRICTIONS: No Dogs are allowed in the vending area. No alcohol consumption allowed during operation. Proper Conduct is a MUST!!

SET-UP: Allowed Wednesday, August 28, from 9:00 AM until 9:00 PM. Display must be complete and ready for operation by 10:00 AM Thursday, August 29.

PLEASE NOTE: *All Guests will be camping on the property throughout the week-end. Make your property secure. Thomas Point Beach is NOT responsible for any damaged or missing property.*
