Limited Food Vending space is currently being offered for the four-day weekend at a flat fee of \$450 for a  $10' \times 10'$  Unit **OR** \$600 for  $20' \times 10'$ . Space is limited and our guests are very selective when choosing their food. Day rates are also available in some instances for mobile food trucks or specialty items.

If you have interest in participating with us for 2022, please fill out the online form! NO LATER THAN June 1<sup>st</sup> 2022. A \$200 inclusion deposit will be due upon acceptance and receipt of your Commitment Contract. **All FEES must be paid prior to set-up. ## 2022 Thomas Point Beach Bluegrass Festival Food Vendor Information

2022 Festival Food Vendor FEES

Food Vendors are charged a flat fee of \$450.00 EACH per STANDARD 10' x 10' space **OR** \$600.00 for EACH EXTENDED 20' x 10' space. A non-refundable deposit of \$200.00 will be charged for each unit and is due upon acceptance to secure your spot. An additional \$40.00 is

charged for <u>each</u> electrical outlet required. **Please note:** Food Vendors who withdraw after August 1st, who damage the festival property or otherwise fail to meet the obligations as stated in the Vendor Contract, will forfeit the deposit. **The additional fees are due before set-up. Fees Include: Two** Week-end Tickets for a standard space or **Three** Week-end tickets with an extended space, as well as Camping the Wednesday before thru Labor Day Monday. Up to Two Additional Employee tickets are available at the discounted rate of 50% for vending staff ONLY. Proof of employment may be requested.

**INSURANCE:** Vendors will be required to provide Thomas Point Beach with a certificate, with this application, indicating no less than \$300,000 General Liability insurance naming Thomas Point Beach as additional insured. THOMAS POINT BEACH OR ITS MANAGEMENT WILL NOT BE RESPONSIBLE FOR ANY ITEMS LEFT ON THE PROPERTY DURING THE EVENT.

**LICENSES:** Vendors are responsible for acquiring the appropriate **state and local licenses**. A Town of Brunswick Application for a Temporary Food Service Establishment License is attached. This must be processed with the town by July 1st and a copy of your license must be received by Thomas Point Beach before August 1. Please Note: If you currently have a Valid Maine Department of Human Services or Department of Agriculture License, be sure to attach a copy to the Town Application along with the payment. This will help speed the processing. Town of Brunswick Health and Licensing inspections will be conducted if you are not currently licensed with the state and the Temporary License will not be issued until after your inspection.

PLEASE NOTE: A Maine State License is required to receive local license.

**CONTRACTS:** Upon acceptance, vendors will be sent and must sign and return the invoice and Commitment contract to Thomas Point Beach, outlining their agreement and obligations, as well as their \$200 confirmation deposit.

**FACILITIES:** Power at Thomas Point Beach is limited. Water is available on the site, but must be carried. No vendor will be hooked up to the water source. Vendors must provide for the disposal of grease, if necessary. **Grease waste is to be removed and NOT to be left on the property anywhere!! Incidental cleaning waste water must be contained and transported to the dump station for disposal. Port-A-Potties are NOT to be used for disposal.** 

**FOOD CONCESSION STAFF:** You will be provided with TWO Admission Passes for a 10'x 10' or THREE for a 20' x 10' or larger (only) per food unit. These passes are to be worn throughout the full week-end and are only available for the actual ticket holder. If more are needed, they must be purchased- a ½ price rate is available for additional employees, but is ONLY intended for STAFF that will be working the event and is limited to 2 discounted tickets.

**HOURS OF OPERATION:** BREAKFAST OPEN by 7:00 AM OTHERS OPEN By 10:00 AM and CLOSE at 10:00 PM daily Thursday, Friday, Saturday and Sunday. **OPTIONAL:** Vendors may begin serving Wednesday, if set-up is complete.

**CAMPING:** Vendors are welcome to camp on the property from Wednesday to Monday at no charge. Camping fees of \$25.00 per night will be charged prior to Wednesday night.

**RESTRICTIONS:** No Dogs in the vending area or Motorcycles must be parked in designated area. Alcohol consumption is NOT permitted during operation. Proper Conduct is a must! Vendors will be asked to leave without refund if rules are violated.

**SET-UP:** Allowed Tuesday or Wednesday. Display must be complete and ready for business no later than 10:00 AM on THURSDAY.
